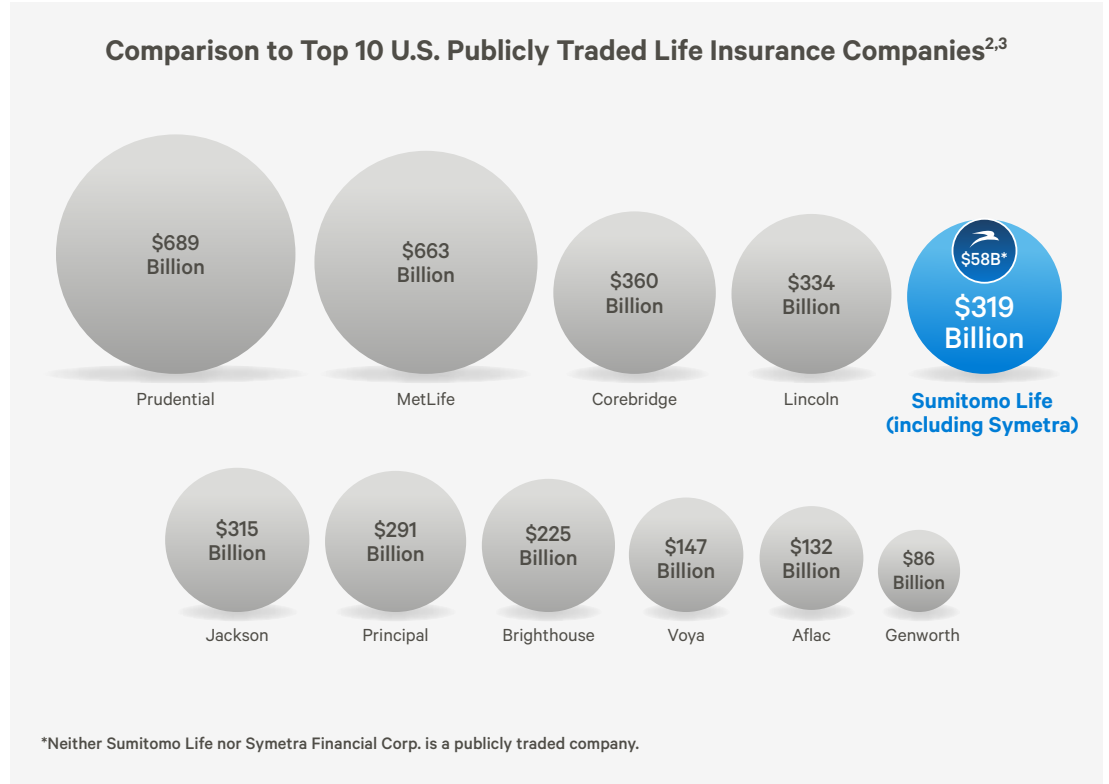
About us

Transparency

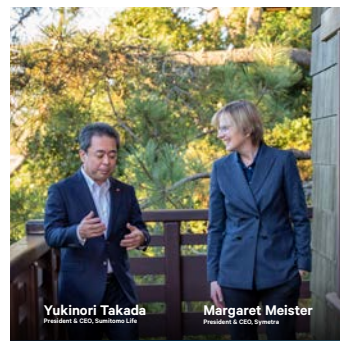
