## **Symetra Announces Leadership Change within Benefits Division**

In addition, Monti has held various leadership positions with MassMutual and UNUM. Monti earned a Bachelor of Science in accounting from Thomas College in Waterville, Maine. He is a certified public accountant (CPA) and a fellow of the Life Management Institute (FLMI).

Raymond has headed Symetra's LAD business since October 2013, adding Select Benefits in 2015. He joined Symetra as senior vice president and chief strategy officer in September 2012 from John Hancock Financial Services.
